

## Solid Waste Senior Discount Application Form

UPDATED: December 2022

Under the City of Upper Arlington’s Solid Waste Program, a property owner who resides in the aforementioned property and is aged 60 years or older can qualify for a discount on their Solid Waste base service fee. To have your next utility invoice correctly reflect this discount, please complete the Senior Discount Application Form (page 2 of this document) and provide a copy of a document that includes proof of age—driver’s license or other official personal identification—to the Finance Department.

- Qualified residents can apply for the Senior Discount at any time. However, the first discount will not be applied until the next semi-annual bill. The discount will not be applied retroactively.
- The Senior Discount only applies to the Solid Waste base fee. It will not be applied to Premium Service or to the City’s additional overheads, such as administrative costs.
- The Senior Discount does not apply to non-property owners, property owners who do not reside at the aforementioned property, or owners of multiple-unit rental properties.
- **Once qualified, there is no need to reapply.**

Below is a breakdown of the current pricing that will be reflected on your semi-annual utility invoice for Solid Waste (annual totals are also provided for your convenience) for Regular Service or Premium Service, with Senior Discount totals under both scenarios.
