




HOW TO PURCHASE A TIME SLOT POOL PASS ONLINE

Click on the "Login" link at the top of the page to log in:



Scroll down on the home page until you come to this portion:



Click on the applicable pass under "Aquatics." On the next page, passes will be listed under "Search Results." You will first select a time slot by clicking the calendar icon to the left of your desired time:

Tremont Pool Time Slot Passes - 650001

The modified pool schedule for 2020 will be comprised of two-hour sessions for up to 100 patrons per pool per session, with a 30-minute disinfection period between sessions. This pass is for open swim. Passes can be purchased up to 7 days in advance and are \$7 per time slot for adults and free for children under the age of 3. You must still reserve a time slot for children under the age of 3. Once you select the time slot you will be directed to calendar to select the date. Only one time slot per day is allowed per family member. After completing your registration you will be emailed a receipt and access ticket. You can either print this ticket out or pull it up on your phone when checking into the pool. YOU MUST HAVE THIS ACCESS TICKET FOR ENTRY. If you do not receive a confirmation email with your access ticket attached please email parks@uaoh.net.

You may arrive to the pool no earlier than 10 minutes in advance of your time slot. Tickets will be scanned prior to the pool opening and guest will be queued in a social distanced line for quick entry into the pool.

POOLS OPEN TO UPPER ARLINGTON RESIDENTS ONLY AT THIS TIME

**Pool Patron Assumption of the Risk and Waiver of Liability Relating to
Coronavirus/COVID-19 and other risks**

The City seeks to limit the spread of COVID-19 by requiring that pool patrons take their temperature prior to entering the City's facilities and stay home if they: 1) are sick, 2) are feeling any symptoms of COVID-19 as identified by the CDC (such as cough, shortness of breath or difficulty breathing, fever, chills, or new loss of taste or smell), 3) have a fever of 100.4°F or above, 4) are suspected of having COVID-19 or 5) had recent exposure to someone with a suspected or confirmed case of COVID-19. By signing below, on behalf of myself and my family, I acknowledge that we will abide with these requirements to self-evaluate and will take my temperature, and/or my child(ren)'s temperature, immediately prior to my reserved time slot and will not enter the City's pool facilities if any of the above apply. We further agree to adhere to all state, local, and other guidelines in place designed to keep people safe. I understand that the City is not monitoring whether I or other participants comply with this requirement.

In addition, I recognize that by being a patron to the City pools and facilities at this time, we are at a higher risk for contracting COVID-19. All adults in the household on this pool reservation must read and agree with the following: With full awareness and appreciation of the risks involved, I, for myself and on behalf of my family, spouse, heirs, executors, administrators, and personal representatives, hereby forever release, waive, discharge, and covenant not to sue the Released Parties for any and all claims from injuries, illness, damage or loss which I have or which may occur to me or to my family on account of my player(s) and family's participation in the program. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my/our attendance at or participation in the City pool facilities.

I agree to indemnify, defend, and hold harmless the Released Parties from and against any costs, expenses, damages, claims, lawsuits, judgments, losses, and/or liabilities (including attorney fees) arising either directly or indirectly from or related to any and all claims made by me or my family against any of the Released Parties due to bodily injury, illness, death, loss of use, monetary loss, or any other injury from or related to the programs use of facilities, tools, equipment, or materials, whether caused by the negligence of the Released Parties or otherwise including but not limited to COVID-19. This agreement may be executed with signatures delivered electronically. By clicking I agree, I have authorized my signature to be formally applied to this document. By clicking agree, I also affirm that the other adults in my household on whose behalf I make this reservation are in agreement with this document.

By signing and clicking agree, I acknowledge and represent that I have read the foregoing Waiver of Liability, understand it and sign it voluntarily as my own free act and deed. I am sufficiently informed about the risks involved. All adults in my household on whose behalf I make this reservation are in agreement with this Waiver of Liability and understand that this waiver applies to them as well.
